Since 1971 BHI has provided and managed a continuum of treatment and housing programs for adults living with severe and persistent psychiatric disorders. Spanning a 18-year survey of our clients, over 91% reported receiving excellent services. Our current programs include:

- Dual Diagnosis Residential Treatment Program
- Berkeley Creative Wellness Center
- CHOICES Housing Program
- Dual Diagnosis Case Management & Psychiatry Services
- Dual Diagnosis Permanent Housing
- Homeless Outreach & Stabilization Team
- Dual Diagnosis Transitional Housing

Our Dual Diagnosis Residential Treatment Program is certified through the State of California Mental Health Department and licensed by Community Care Licensing as a Social Rehabilitation Facility. The Residential Treatment Program, Case Management Program, Homeless Outreach and Stabilization Team, and CHOICES Housing Program serve adults living with serious and persistent psychiatric disorders all of whom have co-occurring substance use disabilities.

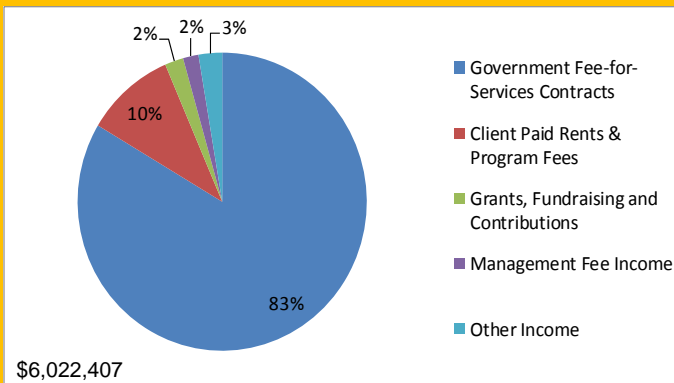

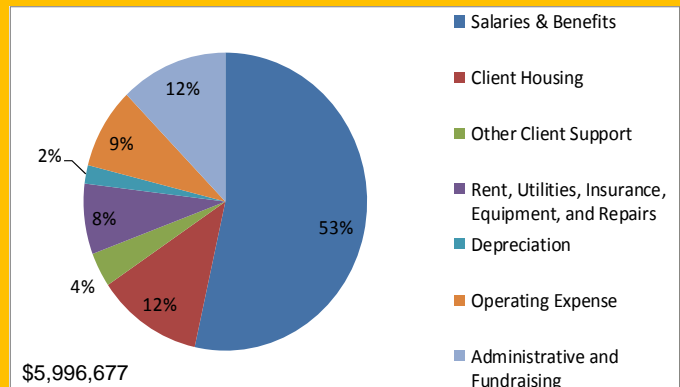

During the twelve months ending on June 30, 2013, BHI has accomplished the provision of the following services:

- **Dual Diagnosis Residential Treatment Program:**
 - 57 Clients received comprehensive residential treatment services.
 - Clients in the program received over 700 individual counseling sessions and participated in over 1,000 therapeutic group sessions.
 - 86% of the clients left the program to pursue independent living.
- **Supported Independent Living Program:**
 - 147 Clients received services.
 - 44 Clients received agency-sponsored housing with supportive services.
 - 84% of the individuals in agency-sponsored housing maintained their sobriety.
 - Clients served reduced their need for hospitalization by 81% compared to the year before entering the program.
- **Berkeley Creative Wellness Center:**
 - 138 Members participated in therapeutic activities such as groups (over 2,000 hours), individual counseling (750 hours), and community-based stabilization in a supportive environment.
 - Over 3,000 hot lunches were provided.
 - The art program was utilized for over 1,500 hours of member participation.
- **Homeless Outreach and Stabilization Team (HOST):**
 - Funded through the Mental Health Services Act (Proposition 63).
 - Targeting single adults who are chronically homeless and living with a major mental illness.
 - Of these, HOST is at enrollment capacity of 90 people.
 - 90% of enrolled members are now stably housed.
 - 50% of enrolled members successfully gained taxable income.
 - 33% of enrolled members are pursuing educational goals.
- **CHOICES – Housing Program:**
 - Funded through the Mental Health Services Act (Proposition 63).
 - Linked 68 enrolled members in subsidized housing.
 - Assisting with countywide affordable housing database website.
 - Developed Housing Assistance Curriculum for use with members.
